## Our programmes

#### **Child Protection**

Our Child Protection Programme combines a range of targeted activities for children and teenagers, a community-based abuse prevention approach, support with social justice cases, and an emergency response to safeguard children in imminent danger that includes care provision.



#### Access to Education



We provide vulnerable children the opportunity to learn with free classes from their early years of schooling, right through to university sponsorship. The lessons follow the Ugandan curriculum with an informal approach, allowing teachers to tailor learning to a child's specific needs.

#### Family Strengthening

Our programme equips parents with vocational and business skills to reduce poverty, ensure food security, and create sustainable income. These include knitting and tailoring, craft making, livestock investments, and carpentry skills training.



# Adam's story

Adam\* is just 6 years old.

"Since I didn't get a chance of going to school, I always had a dream of educating my own children. This dream felt unreachable when my husband abandoned me with my children.

I wasn't making enough from my vending job to send Adam to school. Fortunately, I learnt of this project and that is when the hope of educating my children returned. Adam started going to KCK. KCK volunteers took good care of him in that even on the weekends, Adam didn't want to stay home.

He wanted to go to the KCK centre. He was fed well and also given good education at no cost. Adam loves school because he is now in primary 2 and I know that he will bring back hope in this family through him being educated."

## Different types of gifts

#### A share of your estate

This can be a percentage of what is left over once loved ones are provided for, called a residuary gift, or it can be any percentage you like. As this gift is a proportion of your estate it keeps pace with inflation.

### A fixed sum of money

This is a specific amount, also known as a pecuniary gift. You can choose any amount you like but it's worth reviewing periodically as it may lose value over time due to inflation.

### A specific item

You can also choose to leave a particular item, such as a piece of jewellery, an antique or even a property. A gift like this should be named in your Will.



## Importance of having a Will

#### Peace of mind

A Will ensures that your wishes are executed. Whether that's details you want in your funeral, or things you hope for your loved ones to do.

#### Your impact

Throughout your life, you have the power to make a positive difference. By leaving a gift, you can ensure that the causes you care about continue to be supported after you are gone.

#### Security

A Will makes sure that your loved ones are cared for, offering them financial security for the long term, and providing stability.

#### Cost efficiency

A well-prepared Will can minimise administrative expenses and taxes, leaving more for your beneficiaries.



## FAQ's

#### Where do I start?

# What about inheritance tax?

Any gifts left to charities are exempt from Inheritance Tax. Including a charitable gift can sometimes help reduce the tax on your estate, but it is a complex and often-changing area of law. We advise you visit GOV.UK for the latest information.

# What is an executor and why do I need one?

An executor is someone who takes care of your Will once you have died, to ensure that your wishes are followed through. You can appoint a friend or family member to be an executor, even if they are set to benefit from your Will. Alternatively, for a fee, you can appoint a solicitor or financial advisor.
